<sup>1</sup>The Lash Law. In 1844, a bill was introduced requiring people holding slaves in Oregon to remove them within three years or the slaves would be freed. A section of this bill required free Blacks over 18 to leave Oregon or be subject to trial. *If found guilty, the person was to "receive upon his or her bare back not less than twenty nor more than thirty-nine stripes, to be inflicted by the constable of the proper county."* The punishment was to be repeated every six months until the person departed. This law was soon changed to replace the whipping provisions with ones calling for forced labor followed by removal from Oregon. <sup>2</sup> Second exclusionary law: The second exclusion law was enacted by the Territorial Legislature on September 21, 1849. This law specified that "it shall not be lawful for any negro or mulatto to enter into, or reside" in Oregon, with exceptions made for those who were already in the territory. The law targeted African American seamen who might be tempted to jump ship. The preamble to the law addressed a concern that African Americans might "intermix with Indians, instilling into their minds feelings of hostility toward the white race." The law was rescinded in
